

Cate Buchanan manages the [Surviving Gun Violence Project](#), and published "[Gun Violence, Disability and Recovery](#)" (2014), a unique edited collection in which Professor Thilo Kroll of SDHI contributed.

Cate is also a Managing Partner of [Athena Consortium](#), a specialist firm providing advisory and process management services on gender equality, women's rights in peace processes, violence reduction, victims' rights and inclusive peacebuilding. Cate previously worked for the Centre for Humanitarian Dialogue from 2001, based in Geneva, when she was appointed to establish the Arms Programme.

From 2008 to mid-2013, Cate was a Senior Adviser to the Centre, managing the portfolio of work incorporating gender and women's rights, and security and violence reduction concerns, into the peace process work of the organisation. During this time she also worked for the UN Development Programme and others on weapons control laws and violence reduction policy.

In 2005 she was based in Brazil on secondment to Viva Rio as a human security Adviser. In 2000, she was the Programme Associate for disarmament for the Women's International League for Peace and Freedom in Geneva, and then worked for the International Action Network on Small Arms as the New York liaison officer. Other work experience includes in refuges for women and children escaping violence; as an advocate; a legal researcher; and a campaign organiser.

Cate has a degree from the Australian National University in international relations and development studies and is a Masters candidate in Health Policy at the University of Sydney. Cate is also a Gender Equality Specialist in the [Australian Civilian Corps](#).
